**PLAINTIFF’S REPLY IN SUPPORT OF MOTION FOR
AN AWARD OF ATTORNEYS’ FEES, EXPENSES, AND COSTS TO CLASS COUNSEL
AND A CLASS REPRESENTATIVE SERVICE AWARD**

Before the Court is Plaintiff’s motion for an award of attorneys’ fees, expenses, and costs to class counsel and a class representative service award (Doc. 94) and memorandum in support (Doc. 95). In their joint report dated December 20, 2017 (Doc. 96), the parties reported that Defendant CareCentrix, Inc. (“CareCentrix”) does not oppose an award of \$400,000, inclusive of fees and expenses, and that Plaintiff was limiting the requested award to a total of \$400,000 in reasonable fees and expenses, an amount significantly less than class counsel’s submitted lodestar.

Pursuant to the Court’s preliminary approval order (Doc. 91 at 6), this reply memorandum is due February 1, 2018. Neither CareCentrix nor any class member objected in any way to the requested award of fees, costs, and a \$2,500 service award to Plaintiff Hapka. Because the pending motion, as modified in the joint report, is fully supported by Plaintiff’s submissions and the requested amounts are fair and reasonable, the Court should grant the pending motion following the final approval hearing on February 15, 2018.
